FIRST FAMILIES CORNER

WOULD I LIE TO YOU?

Would your ancestor lie to the federal government? If the lie would help granny to get that \$8.00 per month pension as a widow of an 1812 War veteran, the answer might be yes.

Having no idea what the law said regarding pensions, people often tried to second-guess what their answers should be on the government pension forms. The bulk of the pensions for soldiers and widows of the War of 1812 were issued beginning in 1871, based on reporting what had happened to them over 60 years before. Often the widow (or her children) assumed that to qualify for the pension, the widow needed to have been married to the soldier before his war service, and so they created an earlier marriage date not realizing the actual marriage date was recorded in local records. Others made sure that they reported a marriage date at least nine months before the proven birthdate of the oldest child, because - well, just because.

Proof, you say? You want proof of all those dates, like maybe a family Bible? Alrighty then, create an official Hamic family Bible. Never mind that grandpa enlisted under the name Hammock, which was how the family was spelling it during his lifetime. Never mind that the record pages (birth, marriage, death) in this Bible are all written in the same handwriting, and the same ink. Those fools in Washington will never know the difference. Except, of course, they did.

Who remembers the television show MASH, with the soldier Clinger desperately trying to get a discharge from the army? He didn't seem to realize that the letters that he and his family were writing to Colonel Potter were being collected and compared.

I immediately thought of Clinger when trying to make sense of one branch of my family and their efforts to collect a Revolutionary War pension. Isaac Henderson had enlisted in a New Jersey regiment and had been wounded in both knees. He filed for a pension as an invalid in 1830 but died before the pension was approved. His widow Elizabeth filed to collect the pension due him before his death, and later she filed for a widow's pension. Elizabeth had two children prior to marrying Isaac, Edmund and Prudence Maples, and a son with Isaac named William Henderson.

It is Mrs. Henderson's daughter Prudence Maples who reminds me of MASH's Clinger. Prudence would have been just three years old when her mother married Isaac Henderson, yet there is a document in the pension file in which Prudence states that she was six years old and distinctly recalls her mother's marriage to Isaac Henderson. A few years later, when her mother had died and Prudence wanted to collect the residue of the pension (and to keep it all for herself, it seems) Prudence swore that Edmund was an illegitimate - she did use that word - child of her mother. She falsely claimed that she and William were children of Isaac, born after the marriage, that William had moved away, and she had no idea where he was. According to the census William was still right there in the same county with Prudence. Apparently, Prudence thought that she had to be a child of Isaac, not just of his widow, in order to claim the balance of the pension that was due upon her mother's death.

The employees of the Pension Board must have become quite cynical over the years, reading all those desperate letters

that came pouring in after every war. In 1907, the veterans of the Union army in the Civil War were guaranteed a pension, based on age:

- \$12.00 per month if aged 62-69
- \$15.00 if 70-74
- \$20.00 if 75 or older.

Suddenly men who had previously given an 'about' when asked their age or birthdate started scrambling for proof of an exact date. William Rianhard found himself just a few months short of the magical age 70, so he got his brother Isaac to swear that he had been born Dec 3, 1836. Unfortunately for William, the file already contained papers stating that he had been born in 1837 and also

in 1838. After many, MANY letters back and forth, and even an attempt to alter a family Bible, the government finally settled on a birth year of 1838 and William didn't get his increase until he was entitled to it.

Mark Twain nailed it when he said, "If you tell the truth, you don't have to have a good memory." In those early days before carbon copies – maybe some of our ancestors should have taken that to heart.

Using Evernote to Capture Notes and Ideas

This presentation will cover how to set up a free Evernote account, how to create and edit notes, and how to clip online articles into Evernote using the Evernote Web Clipper browser extension. Information can also be emailed directly into Evernote. Learn to organize Evernote notes into notebooks and notebooks into stacks. Notes can also be tagged for easier finding, such as for specific surnames, locations, and document types. Collaborate with others by sharing Evernote notebooks or individual notes. Evernote can also be used to create research to-do lists and reminders.

Drew Smith is the genealogy librarian at the University of South Florida Libraries in Tampa. In 1996, he founded the mailing list GENEALIB for genealogy librarians, and he continues to administer it for nearly 1000 subscribers. In 2016, Drew received the Filby Award for Genealogical Librarianship, presented by the National Genealogical Society. He is co-host of *The Genealogy Guys Podcast* and host of the *Genealogy Connection* podcast.

He writes a regular productivity column for the *Association of Professional Genealogists Quarterly*. He wrote *Organize Your Genealogy: Strategies and Solutions for Every Researcher* and coauthored *Advanced Genealogy Research Techniques*.
